Title of Doctoral Thesis: *Hermoupolis (Island of Syros): the Shipbuilding Centre of the Sailing Merchant Marine, 1830-1880*, Corfu, 2010. The thesis explores the shipbuilding industry of the most important commercial and maritime centre of the Aegean in the 19<sup>th</sup> century. It highlights economic, institutional, technical and social aspects of the shipbuilding activity and its protagonists, and places them in historical context. The thesis employs interdisciplinary theoretical tools from economic geography, economic sociology and institutional economics and adopts new interpretive models and views with relation to Modern Greek historiography on the subject.
