This book consists of a collection of some of my articles, reworked and revised. Two of its essays ("What is populism?" and "Workers against workers: national preference demands against refugees in Athens and Piraeus 1890-1922") are based on the research conducted for the papers n.3 and 5 of my papers in peer-reviewed journals cited below. The rest were published in non-academic journals, but written according to the rules of the discipline of history. Their topics include the establishment in Greece of the permanent employment of civil servants in 1911 and its reasoning, the conflict over the establishment of the holiday of Sunday in 1909, the discourse against profiteering in 1914-1924 and the issue of market regulations, the essence of fascism and the fascism in interwar Greece, the views of the 19th century socialist Stavros Kallergis about nationalism and internationalism, about the Greek revolution of 1821, the Polytechnio uprising in 1973 and so on.
